TUITION AND FEE SCHEDULE  
2010-2011**

**Application Fee (New Students Only – Kindergarten through 12<sup>th</sup> grade)** – There is a \$100 non-refundable application fee for each new Kindergarten – 12<sup>th</sup> grade student making application to enter ASCS.

This \$100 fee will be applied to the Enrollment & Book Fees once the student has been accepted and enrolls at ASCS.

**Enrollment and Book Fees:** To be paid in full at the time of each student's enrollment (Non-refundable).

A student is not enrolled or guaranteed placement until the Enrollment & Book Fees are paid and a financial contract has been agreed to.

**Multiple Student Tuition Discount:** Families with two or more children will receive a tuition discount for each child as follows: (Student in the highest grade level is considered as the first child.)

2<sup>nd</sup> child – 10%                  3<sup>rd</sup> child – 25%                  4<sup>th</sup> + child – 40%

**Payment Plan Options:**

- 1) **Payment In Full:** Families paying tuition and capital development fees in full must submit payment by June 1, 2010 to receive a discount of 3.0% off the net amount owed after all other discounts have been applied.
- 2) **Monthly Payment Plan:** Under the monthly payment plan, tuition is due on the first day of each month beginning July 1, 2010 through May 1, 2011. Students enrolling after July 1 will be assessed the equivalent of one month's tuition and capital development fee immediately upon enrolling with the balance spread over the remaining months through May 1, 2011.

**FACTS Tuition Management:** For the convenience of our families and to make the school more efficient, ASCS is encouraging all families to sign up for FACTS Tuition Management's automatic monthly withdrawal program. There is no added fee for using the automatic bank draft system using your checking account. For those families wishing to pay by credit or debit card, there is an additional convenience fee assessed to the payment. Enrollment in FACTS can be done through the school office or online at [www.shoreschristian.org](http://www.shoreschristian.org).

The following families are required to enroll in FACTS Tuition Management's automatic monthly withdrawal plan:

- a) Families who have enrolled after the 2008-09 school year and who do not pay in full by June 1.
- b) Families who receive financial assistance from ASCS.
- c) Families who, at anytime, have failed to remain current in their payments.

**Late Fee:** A late fee of \$40.00 will be assessed if there is an outstanding balance on the sixth of the month.

**Financial Aid:** Families in need of financial assistance must apply for aid using our outside provider, FACTS Grant & Aid. Financial aid applications can be submitted to FACTS along with a \$25 application fee paid to FACTS by going online at [www.shoreschristian.org](http://www.shoreschristian.org) or using forms available from the school office. Financial aid is only available to students in Kindergarten through 12<sup>th</sup> grade. Returning families must apply for financial aid by April 30, 2010. Those returning families who apply after April 30 will be reviewed based on what remaining funds are available for financial aid.

**Athletic Fee for Secondary Campus:** \$50.00 per student athlete/per sport

**Resource Program Fees** (In addition to tuition):

Scholar's Lab (Elementary): \$175.00/month.

Smart Start (Elementary): \$250.00/month Math & reading taught 5 days per week with classroom modifications.

\$225.00/month One subject (math or reading) taught 5 days per week and assistance with a second subject (math or reading) with modifications and IEP.

\$100.00/month Tutoring (two 30 minute sessions per week – possible modifications)

Resource Program (7<sup>th</sup> – 12<sup>th</sup>): \$250.00/month (5 days a week, 1 credit)

\$150.00/month (3 days a week)

Family Discount:

Two children in a Resource Program – 10% off Resource bill.

Three or more children in a Resource Program – 20% off Resource bill.

**New Families:** Upon completion of an application, new families coming into our school should schedule an appointment with the principal/dean for an interview. After acceptance, the new family must meet with the business office to finalize the financial contract. A student is not enrolled or guaranteed placement until a financial contract is completed and Enrollment and Book Fees are paid.
